STATEMENT OF COOPERATION AND FINANCIAL AGREEMENT

Monthly statements will be sent by email. Grade cards will not be released if the account is delinquent for any reason. **Accounts delinquent 15 days will require communication with the finance office by the 30th of the month in order for the student(s) to continue to attend VCA.** No student will be permitted to graduate unless the account is current. If our account is turned over for collection, we agree to pay any fees the school may incur, which we understand could double the amount owed the school at that time.

We give permission for our child to take part in all school activities, including sports and school-sponsored trips away from the school premises. We absolve the school from liability to us or our child because of any injury to our child at school or during any school activity. We agree to encourage our child in learning Bible truths and in all other phases of the school curriculum. We agree to abide by all the rules and regulations of the school and to support the school in any necessary disciplinary action. Even though we may not personally agree with all of the standards, we promise to make sure that our student(s) comply while enrolled in VCA.
