

# Parent - School Contract

## Calvary Christian School ~ 7-12<sup>th</sup> Grades



The purpose of Calvary Christian School is to assist the Christian home by teaching academics and the Truth of God's Word in an environment where young people can receive that Truth and learn how to apply it wisely to their lives. Every effort is therefore made to ensure that Calvary teachers, textbooks, extracurricular activities, rules and enforcement, enrollment policies, etc. are true to principles taught in God's Word (the Bible).

**PARENT/STUDENT HANDBOOK:** I and my student have fully read all sections of the Parent/Student Handbook that apply to Middle & High School. I pledge to fully cooperate with all standards of conduct, financial obligations, procedures, rules and discipline that are described in the Handbook or that might otherwise be implemented by the school. I will encourage my child(ren) to do the same.

**DOCTRINE:** I have read the full CCS Statement of Faith, I understand that my child(ren) will be taught Bible truth in harmony with that Statement, and **I will support and not in any way contradict** these teachings. I understand that doctrine, principles of life, standards of behavior, etc. will be taught from Scriptures as held by fundamental Baptist churches throughout history and as taught by Calvary Baptist Church. I understand that if any 7-12<sup>th</sup> grade student voices opinions contrary to Baptist doctrine or the church and school's Statement of Faith, whether on or off property, he/she may be asked to not return the following year, or may be dismissed from school during the current year. I further understand that arguing against a teacher about doctrine or any area of the school Statement of Faith will be grounds for immediate dismissal.

**STANDARDS of CONDUCT:** Calvary Christian school seeks to provide an environment conducive to the spiritual growth and development of young people who are not yet mature Christians. Calvary Standards of Conduct, as detailed in the Parent/Student Handbook, are based on biblical imperatives that are necessary to provide such an environment. Calvary's atmosphere of positive Christian standards of conduct, good scholastic planning, and intimate personal interest between faculty and student, provides for a wonderful opportunity for strong Christian character to develop.

In the spirit of working with the school to develop my child's Christian character, I pledge to fully support the school's Standards of Conduct and will hold my student responsible to respect and obey all aspects of those standards. **Selected examples follow:** (All standards are detailed in the Handbook.)

- Students are responsible to respect and obey authority without being critical, dress in compliance with the school dress code at all times required, etc.
- Students are responsible to NEVER bring a weapon to school, cheat, use profanity, use tobacco or e-cigarettes, gamble, dance, drink alcoholic beverages, use narcotics or other illegal substances, or engage in illegal activities.
- Students are responsible to strive to maintain Christian standards of morality, honesty, kindness and courtesy.
- Students are responsible to attend a Bible preaching church each week and perform six hours of church-related Christian service each quarter.
- Students are responsible to deal with sin according to scriptural principles.
- Students are responsible to interact with each other in love as brothers and sisters in Christ.
- Students are responsible to the school to help keep it godly.

### STATEMENT of COOPERATION:

- I will cooperate with the school in **any health measure** that is necessary to safeguard or promote the health of all students in the school. In the event of a contagious illness, the parent will remove the student and not allow him to return until all danger of contagion is passed.
- I will cooperate with the school in its enforcement of **compulsory attendance regulations**. (Limits: 7-8<sup>th</sup> = 20 per yr; 9-12<sup>th</sup> = 10 per sem).
- I give permission for **my child's picture** to be used in brochures, videotapes, DVD's, website or other publications of the church or school or its affiliate entities, if a school photographer or videographer takes a picture of my child or a group picture with my child in it.
- I give permission for **emergency medical treatment** to be administered in event of illness or injury to my child at school or during a school activity. In all emergencies, Calvary Christian school has permission to take such reasonable measures as are necessary to the welfare and safety of my student.

- I give **permission** for my child to **take part in activities** sponsored by CCS, including field trips, athletic events, etc., away from the school premises.
- I give full discretion to the school regarding my child's discipline, including all aspects of discipline detailed in the Handbook, suspension, and expulsion from the school program.
- I understand that Calvary Baptist Church and Christian school will **not be liable** for accidents or illness which occurred to the student while he is in school unless it can be proved that the accident or illness was a direct result of our willful negligence. I further understand that CCS will exercise reasonable care and judgment in all matters related to the welfare and safety of the student. In cases of accident or illness to the child, CCS will promptly take such reasonable measures as are in the best interest of the child and will notify the parents as soon as possible.

I agree to hold the church/school and its agents harmless for any liability to my child or any parent or guardian thereof because of any claims on behalf of my child against the church/school or any agent thereof because of any injury to my child. Should legal action, for any reason, be taken against Calvary Baptist Church or Christian School or any employee or agent thereof on my child's behalf, and the church/school or its agents **not** be found at fault, I agree to pay any attorney fees, court fees, damages or other costs that the church/school or its agents should incur to defend itself against such action.

- I understand that should my **marital status change**, it is my responsibility to have a corrected Statement of Cooperation updated, signed by the new parent or legal guardian, and delivered to the school office.

**FINANCIAL OBLIGATION:** I have read the complete **CCS Financial Policies** document that governs the present (or coming) school year, and I agree to pay all financial obligations according to the terms therein. I understand that ...

- The school will enroll my child(ren) in the "Smart Tuition" account management service.
- I am responsible to pay all charges due for my student(s) on or before the **20<sup>th</sup>** of each month according to the 10, 11 or 12 mo. payment plan that I have chosen.
- Smart Tuition will charge a \$40.00 late fee for any balance that is outstanding after the **20<sup>th</sup>** of any month.
- Smart Tuition will charge \$30.00 for a failed electronic transaction or dishonored check.
- If my account becomes 60 days past due, my child(ren) may not attend classes until the account is brought current or a revised payment plan is approved and accepted by both parents and school.
- No end of the year records, report cards, diplomas, or transcripts will be issued until the account is paid in full.
- A monthly finance charge of 1.5% (18% annual) will be applied to the outstanding balance of any withdrawn family until the unpaid balance is paid in full.
- I may request to have my payment plan restructured if unusual circumstances require special arrangements. (Only the principal can approve special arrangements.)
- These policies must be maintained to insure the financial stability of the school.

**NONDISCRIMINATORY POLICY:** Calvary Christian school has a racially nondiscriminatory policy. That is, we do not discriminate against applicants and students on the basis of race, color, and national or ethnic origin.

**STUDENT'S COMMITMENT:** I have carefully read this contract and all sections of the Parent/Student Handbook that apply to 7-12<sup>th</sup> grades. By signing below, I am promising to willfully and gladly abide by all standards outlined therein.

**PARENT'S AGREEMENT:** I have carefully read this contract and all sections of the Parent/Student Handbook that apply to middle and high school. I understand that this is a binding contract between CCS and my family, I understand and agree to all points, and I promise to abide by all terms therein as long as my child shall attend Calvary Christian school.
