  - ✎ 1 page biography or company history
  - ✎ Minimum of 2 reference letters with contact information.
  - ✎ Statutory Declaration that all Subs/Suppliers have been paid
  - ✎ List of all trades and suppliers used for the project with Contact Information
- Nominees must be a member in good standing of FMCA for the 2019 membership year
- The decision of the awards committee is final and not subject to appeal
- All submissions in support of a nominee for this award become the property of the Fort McMurray Construction Association.
- The award recipients in each category will be announced at the 2019 Awards Luncheon in March 2019.
