CONSIGNMENT AGREEMENT

This agreement is between Legendary Motors LLC of Massachusetts hereafter know as "LMLLC" and _____ hereafter known as "Owner".

1. The Owner guarantees free and clear, negotiable title. Title must be in owner's name or consignor must have proper written authorization from owner to consign vehicle. Owner must provide a copy of both sides of the title at the time of consignment. LMLLC reserves the right to withhold all funds until delivered of free and clear, negotiable title. Owner must provide written proof of payoff if applicable and authorizes LMLLC the right to obtain the title directly from the lien holder.
2. All vehicles must be fully insured by the owner. Proof of insurance is required. If insurance is required please contact LMLLC for a recommendation. Owner authorizes LMLLC to drive the vehicle for the purposes of demonstration purposes, repairs, testing etc.
3. Vehicle is to be delivered to LMLLC in clean and in good running and driving condition unless other previous arrangements have been made. All deficiencies or needed repairs must be indicated in writing upon signing of agreement. Should a problem be identified you will be notified by LMLLC and asked to repair the problem as soon as possible. All repairs are at the Owner's expense. The vehicle will be kept in a clean presentable manner by LMLLC but will not be detailed unless requested and all expenses will be paid by the owner.
4. If the vehicle is not in LMLLC possession, the Owner agrees to the deliver the vehicle, documentation and any spare parts indicated with the sale of the vehicle to LMLLC with 24 hours of securing a buyer.
5. I agree to hold LMLLC harmless against claims of any nature, including weather, acts of God, and especially those of vehicle originality, Vehicle Identification Numbers and Matching Numbers.
6. All advertising placed by the Owner prior to consigning the vehicle with LMLLC must be cancelled or removed. The Owner grants LMLLC exclusive right to sell the vehicle while on consignment. If the Owner sells the vehicle while under this agreement, the Owner agrees to pay all consignment fees and expenses.
7. I the Owner agree to allow LMLLC to deduct the consignment brokerage fee as listed in the schedule below and any authorized expenses from the proceeds of the sale of my vehicle. The brokerage fee schedule is calculated as follows: 10% for the first \$25,000, 8% for any additional monies between \$25,000-\$50,000 and 6 % for any monies above \$50,000 for a cumulative total.

Vehicles \$10,000 to \$25,000	LMLLC fee 10%
Vehicles \$25,000 to \$50,000	LMLLC fee 8%
Vehicles over \$50,000	LMLLC fee 6%
