Under the Canadian Human Rights Act, federal employers have a legal duty to reasonably accommodate their employees' childcare obligations (by, for instance offering predictable work schedules where possible).5

The Government of New Brunswick is currently deliberating amendments to the NB Human Rights Act that would protect workers from discrimination based on family status. This clause could eventually expand the duty to reasonably accommodate childcare obligations to all NB employers!
