



NOTICE AND REQUEST FOR COMMENTS

The Financial and Consumer Services Tribunal (Tribunal) is proposing to amend its proposed *Rules of procedure*. The proposed *Rules of procedure* were previously re-published for a 30-day comment period from June 28 to July 28, 2017. The proposed amendments add amounts recoverable as investigation and hearing costs pursuant to section 44 of the *Financial and Consumer Services Commission Act* to the *Rules of procedure*. These costs will simultaneously be removed from the Financial and Consumer Services Commission Local Rule 11-501 Fees. The applicable costs will remain the same.

The proposed amendments are included in Schedule "A".

**Amendment Instrument to
the Proposed *Rules of Procedure***

1. Part 14 is amended:

(a) in section 14.1, by repealing paragraph (1) and replacing it with the following:

"(1) The Tribunal may order a person to pay the following fees and expenses in relation to an investigation pursuant to section 44 of the *Financial and Consumer Services Commission Act*:

- (a) \$50 per hour per person for time spent on an investigation by any employee of the Commission,
- (b) disbursements properly incurred by the Commission for an investigation,
- (c) fees paid or payable for an expert,
- (d) disbursements properly incurred by an expert,
- (e) fees paid or payable for legal services, and
- (f) disbursements properly incurred in connection with the provision of legal services."

(b) in section 14.1, by adding the following after paragraph (1):

"(2) The Tribunal may order a person to pay the following fees and expenses in relation to a hearing pursuant to section 44 of the *Financial and Consumer Services Commission Act*:

- (a) \$2,000 for each day or partial day of hearing,
- (b) \$50 per hour for each employee of the Commission for time spent at a hearing,
- (c) disbursements properly incurred by any employee of the Commission for a hearing,
- (d) fees paid or payable for an expert or witness,
- (e) disbursements properly incurred by an expert or a witness,

- (f) fees paid or payable for legal services,
 - (g) disbursements properly incurred in connection with the provision of legal services, and
 - (h) \$50 per hour for each employee of the Commission for time spent preparing for a hearing."
2. This Instrument comes into force on xx, 2017.
