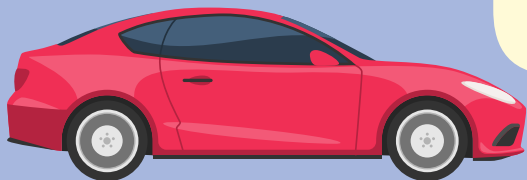

Can a payday lender force me to sign over items I own as payment?



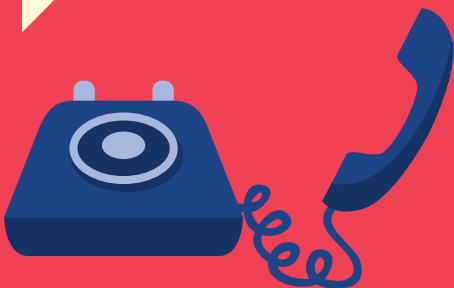

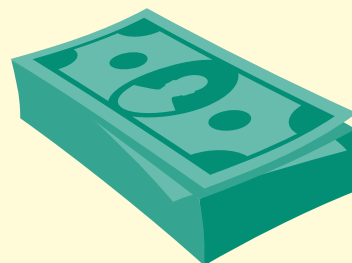

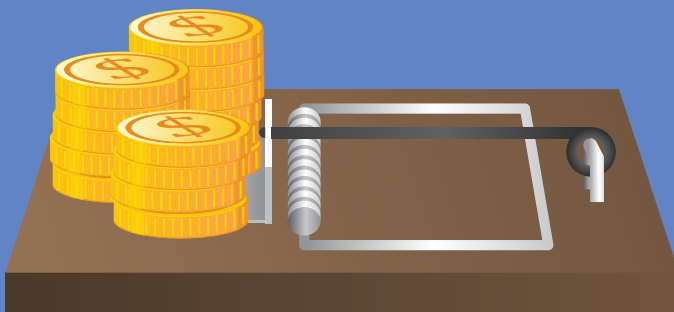
